

## INDICATION OF INTEREST FOR WATER SERVICE – LEVI WATER SUPPLY CORP.

You have expressed an interest in acquiring a water meter or water meters from Levi Water Supply.

Please complete the Application for Service (Standard or Non-Standard) to provide the physical address for the requested water meter or tract of land that you currently own, have a purchase agreement for, or have an interest in purchasing. The Application for Service does also include regulatory requirements and also procedures and requirements included in the operating tariff of Levi Water Supply Corporation.

The ability for Levi Water to provide water service to the requested property includes the availability of water and also the ability of the current distribution system of Levi Water System to provide service to the requested location.

Levi Water Supply is under the jurisdiction of the Southern Trinity Groundwater Conservation District (STGCD). The STGCD has issued a Historic Use Permit (HUPP) and a Non-Historic Use Permit (NON-HUPP) to Levi Water Supply which limits the amount of water that can be withdrawn from the aquifer on an annual basis by Levi Water Supply Corporation. Based on the meter count that Levi Water Supply is committed to serve, Levi has reached the maximum number of meters that they can serve and not exceed the usage permit. Levi Water is currently working to obtain an additional water source.

When an additional water source is identified, engineering and environmental studies will be required for either the drilling of another well and/or installing a pipeline to transport water to the Levi Water System. Once the studies are completed, a construction plan will be submitted to the Texas Commission on Environmental Quality (TCEQ) for their approval.

When the approval is received from TCEQ and a contract for construction is finalized, Levi will then be able to determine when the additional water source will be available to serve new requests for water service. The applications will be considered in the order they have been received where the engineer can better determine if the distribution system for Levi can support additional water service at the requested location. Any improvements that will be required for water service at the location requested will be at the expense of the applicant (single or multi-meter requests). Multiple meter requests will be responsible for all distribution system cost on their property, including expense incurred by the Levi Engineer, inspection costs, land and survey costs, cost to obtain easements, and legal expense incurred by Levi. Water meters can only be installed along roads or streets that are approved as public roads.

The check that you have submitted with your application is considered to be an “indication of your interest” to purchase a water meter or meters. The amount will be applied as the engineering evaluation cost. If you withdraw your request prior to the engineer evaluation, Levi will refund your deposit. The fee is \$150.00.
